NOTICE OF REQUEST FOR COMMENT AND PUBLIC HEARING ON DRAFT MAJOR AMENDMENT TO THE TRANSIT CAPITAL COMPONENT OF THE 2020 – 2023 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) FOR THE SHEBOYGAN METROPOLITAN PLANNING AREA

All interested persons are invited to comment on a draft major amendment to the transit capital component of the 2020 - 2023 Transportation Improvement Program (TIP) for the Sheboygan Metropolitan Planning Area. The TIP contains a program of transit operational funding and capital projects, elderly and disabled transit operating expenses and capital projects, bicycle and pedestrian transportation projects, and street and highway improvement projects which are eligible for federal funds in calendar years 2020, 2021, 2022 and 2023. The original 2020 - 2023 TIP was approved in October 2019, and minor amendments to the 2020 - 2023 TIP were approved in January and June of 2020. The 2020 - 2023 TIP (including amendments) implements the Update to the Year 2045 Sheboygan Area Transportation Plan (SATP).

Shoreline Metro has requested three additions and one modification to the transit capital component of the 2020 – 2023 TIP. The additions involve (1) replacement of five (5) 35-foot fixed-route buses funded through the Congestion Mitigation and Air Quality (CMAQ) improvement program; (2) replacement of two (2) 35-foot fixed-route buses funded through the Volkswagen Diesel Emissions Environmental Mitigation Trust Fund; and (3) replacement of one (1) 35-foot fixed-route bus funded by Federal Transit Administration (FTA) Section 5339 program; all of these bus replacements involve local matching funds. The modification involves changing the funding source for various transit administrative and maintenance facility improvements for Shoreline Metro; while this project was initially all locally funded, the amendment would now provide 100 percent federal financing through special FTA Section 5307 funding provided from the "Coronavirus Aid, Relief, and Economic Security" (CARES) Act.
