

**NOTICE OF REQUEST FOR COMMENT ON THE DRAFT 2020 PUBLIC  
PARTICIPATION PLAN UPDATE FOR THE SHEBOYGAN METROPOLITAN  
PLANNING ORGANIZATION (MPO)**

The Bay-Lake Regional Planning Commission (BLRPC) has prepared a draft 2020 update to the Public Participation Plan for the Sheboygan Metropolitan Planning Organization (MPO) for public review. This 2020 Public Participation Plan Update is intended to describe how the BLRPC staff will, to the best of their ability, provide the opportunity for public input and understanding of transportation plans and programs to all residents of the Sheboygan metropolitan planning area, especially to those persons who have been historically underrepresented in the planning process.

The draft 2020 Public Participation Plan Update for the Sheboygan MPO includes changes to the MPO's public participation process resulting from the "Fixing America's Surface Transportation (FAST)" Act, which "requires that the planning process include public ports and private transportation providers (specifically intercity bus operators), and further encourages MPOs to consult during this process with agencies and officials of other types of planning activities, including tourism and natural disaster risk reduction." These requirements are in addition to public participation requirements found in previous legislation.
