### Amendment #1 to the 2016 Coordinated Public Transit – Human Services Transportation Plan for Kewaunee County, Wisconsin

The "Fixing America's Surface Transportation" (FAST) Act requires the county Coordinated Public Transit – Human Services Transportation Plan to identify an approved program of projects prior to distribution of funds from the Section 5310 (Enhanced Mobility of Seniors and Individuals with Disabilities) program. Two other programs that were previously included in Coordinated Public Transit – Human Services Transportation Plans (Section 5316, the Job Access and Reverse Commute Program (JARC), and Section 5317, the New Freedom Program) were discontinued in the previous federal surface transportation legislation (the "Moving Ahead for Progress in the 21st Century" (MAP-21) Act), but were rolled into other existing programs; Section 5316 was rolled into Section 5311 in the case of Kewaunee County, while Section 5317 was rolled into Section 5310; these changes remained intact in the FAST Act.

The Bay-Lake Regional Planning Commission and the Kewaunee County Human Services Department, after consulting with the Kewaunee County Transportation Coordinating Committee and with interested parties in Kewaunee County, has updated the 2016 Coordinated Public Transit – Human Services Transportation Plan for Kewaunee County, Wisconsin, to reflect the program of projects for fiscal years 2017 through 2021.

The amended Table 6 which follows supersedes the previous version of Table 6 outlining recommended projects found on page 18 of the 2016 Coordinated Public Transit – Human Services Transportation Plan for Kewaunee County, Wisconsin.

# Kewaunee County Transportation Committee Meeting June 13, 2017 10:30-12:00 at 810 Lincoln Street

Present for the meeting were David Cornelius, Tracy Nelson, Maureen O'Shea, Laurie Bouche, Melissa Annoye, Lynn Clark, Jodi Vandervest, Tina Paral, Daniel Daul, Bob Mattice, Pam Busch, Mary Kay Messmann, Tracy Nollenberg, Marsha Batt, Wendy Hutterer and Jeff Agee-Aguayo from Bay Lake Regional.

The Transportation Committee meeting was called to order at 10:30 with introductions following.

Bob Mattice provided updates on the Human Services agency. He reported that Dr. Ken Downing has been hired for a part-time psychologist position in the Behavioral Health department to provide counseling services for 20 hours per week. The open CCS facilitator position has been filled by Jacob Kumpfer. The Economic Support position is still open with 25 applicants currently being reviewed.

Melissa Annoye provided updates for the Transportation Program beginning with ridership numbers for March, April and May. The Algoma Bus total was 384 which is down from last year due to regular riders no longer using the service. Melissa stated that it will be necessary to do some recruiting of new riders. There have been a few days that the Algoma Route was shut down due to no rides scheduled. The Driver Escort and Grant Van number of over 800 is up considerably higher than last year's 637. The Kewaunee Van number is also higher at 140 compared to last year's 118. The increase for the White Van is due to the Kewaunee Fitness Center route and also an increase in the number of rides that the nursing facilities are providing their residents.

Melissa went on to inform the committee that she had recently met with the Senior Center Committee and that they were interested in hearing updates on the Transportation Program. They would like to have minutes provided to them. They also voiced interest in having more transportation options for the city of Kewaunee. Melissa informed them that a previous study for such a program didn't provide enough interest to go forward. They then had a discussion regarding the possibility of trying out a regular bus/van route for the city of Kewaunee comparable to the Algoma route. Melissa asked the Committee for input or thoughts about the possibility of starting such a program. It was thought that it would need to be heavily advertised and started out at only one day a week to see how it goes. Maureen O'Shea suggested offering some type of incentive to consumers to utilize the program. Melissa will be moving forward with planning.

Laurie Bouche followed with updates of the Volunteer Driver Program. She stated that there has been an increase in the number of developmentally disabled consumers being served. Some of these consumers have been referred to the program through the DVR to set up rides for getting to and from workplaces.

Laurie reported that meal site numbers are down considerably. There was a discussion on possible ways or places to advertise to try to draw more consumers in. Laurie stated that there are currently 26 volunteer drivers with 1 possible new recruitment.

Melissa Annoye stated that there will be a Volunteer Driver training held on June 15<sup>th</sup>. The focus of the training is on serving consumers experiencing dementia. A speaker from the Alzheimer Association will be presenting. Melissa reported that she would like to see the program continue to provide trainings on consumer diversity. Laurie stated that she and the volunteer driver(s) have had to come up with a creative ways to serve special needs consumers.

Meal site ride rate updates – Melissa stated that there had been concerns voiced by the ADRC Committee regarding the 2017 ride rate increase. Melissa and Laurie went out to the meal sites to see how much interest there would be in having a route to the meal sites at a reduced rate. Melissa said that if we would be proceeding with such a program, she would like to propose a rate of \$1.00 per stop to stay in line with the Algoma Bus. A motion was made by Tracy Nelson to move forward with providing consumer rides to and from the Kewaunee meal site for a reduced rate of \$1.00 per stop. Seconded by Marsha Batt. Motion carried.

Update on vehicle purchase for 2018 – Melissa asked for input regarding the process of writing the 53.10 Grant application for the vehicle purchase as she has not previously written this grant. A motion was made by Laurie Bouche to move forward with the 53.10 grant process. Seconded by Dan Daul. Motion carried.

Jeff Agee-Aguayo of Bay Lake Regional Planning Commission discussed the amending the 2016 Coordinated Public Transit-Human Services Transportation Plan for Kewaunee County. Jeff stated that he had been contacted by Tracy Nelson from East Shore Industries to make an amendment to their program project plan. Originally ESI was looking at one new vehicle request for 2017 and two for 2018 but would now like to request two for 2017 and one for 2018. It was also discovered that the project plan years for Kewaunee County would need to be amended. Four items will need to be amended - 2018 entry will shift to 2017, 2020 will shift to 2019. A motion was made by Bob Mattice to approve amendments as presented by Jeff Agee-Aguayo. Seconded by Mary Kay Messmann. Motion carried.

Next meeting was scheduled for September 12 at 10:30 am at 810 Lincoln Street.

A motion to adjourn was made by Dan Daul and seconded by Laurie Bouche. Motion carried, meeting adjourned.
