# 2012 Comprehensive Economic Development Strategy

The Bay-Lake Regional Planning Commission has completed a draft of its 2012 Comprehensive Economic Development Strategy (CEDS). The 2012 CEDS will be available for review beginning November 2, 2012, through December 4, 2012. The draft document can be viewed by clicking on the "Economic Development Tab" on the Commission's website. This 30-day public review period is required to enable stakeholders, businesses, and other interested parties to examine and provide input on the document. Written comments via mail or email must be received by no later than 4:30 p.m. (CST) on December 4, 2012.

The preparation and adoption of the CEDS ensures that the Bay-Lake Region maintains its Economic Development District (EDD) status through the Federal Economic Development Administration (EDA). This designation allows community and regional projects listed in the document to apply for funding through a variety of EDA programs. In addition, the CEDS provides a framework for regional economic development through the preparation and implementation of a comprehensive set of goals, objectives and strategies that were developed based on the economic environment of the region.

The Commission's Natural Resources Planner, Angela Pierce, attended the 2012 **USEPA Urban Waters** National Training Workshop in Washington, DC last week (October 23-25). Angela was invited to represent the Commission as a recipient of an Urban Waters grant for a beach improvement action plan at Bay Beach in Green Bay. The objective of the workshop was to provide an opportunity for networking with other current and past grant recipients. The



workshop was very beneficial and offered some ideas to make the Bay Beach project better - such as ways to engage the public and to help bring input from low income and minority citizens to the table. These ideas will be used to obtain good citizen participation at an upcoming (yet-to-be planned) community visioning workshop. A technical workshop will also be held to gather input from the scientific community about the impairments to Bay Beach becoming swimmable again. The Commission's GIS Coordinator, Josh Schedler, has been appointed to the Wisconsin Geographic



# Lower Green Bay and Fox River Area of Concern RAP Update Public Review Period

The Lower Green Bay and Fox River are one of 43 Great Lakes Areas of Concern (AOC) established in the mid 1980s because of major environmental problems caused by toxic substances (primarily polychlorinated biphenyls or PCBs), excessive nutrient and sediment loads from point and nonpoint sources, and physical habitat alterations. Thirteen beneficial use impairments (BUIs) were identified for this AOC, two of which were listed as suspected at that time. In the twenty-three years since the original Remedial Action Plan (RAP) local, state, and federal partners have made significant progress toward addressing the causes of impairments within the AOC. However, no BUIs have been removed and the Lower Green Bay and Fox River is still very much an Area of Concern. The 2012 Stage 2 RAP Update for the Lower Green Bay and Fox River Area of Concern has been drafted to address the issues and is now available for public review here.
