

**NOTICE OF REQUEST FOR COMMENT ON THE DRAFT UPDATE TO THE YEAR
2045 SHEBOYGAN AREA TRANSPORTATION PLAN (SATP)**

All interested persons are invited to comment on the draft Update to the *Year 2045 Sheboygan Area Transportation Plan (SATP)*. The draft Update to the *Year 2045 SATP* includes: an introduction to the plan; discussion of the metropolitan transportation planning process; a profile of the Sheboygan metropolitan planning area; a mission statement, goals and objectives; an extended updated inventory of the existing condition of the transportation network; and discussion of the relationship between transportation and land use in the Sheboygan metropolitan planning area. The draft Update to the *Year 2045 SATP* also contains a recommended transportation plan involving: various street and highway improvement projects; transit funding, projects and strategies; bicycle and pedestrian transportation projects, policies, programs and strategies; freight policies and strategies; intercity passenger policies and strategies; safety projects, policies and strategies; security policies and strategies; transportation system resiliency and reliability policies and strategies; policies and strategies regarding reduction or mitigation of stormwater impacts of surface transportation; policies and strategies regarding enhancement of travel and tourism; policies and strategies regarding connected and automated vehicles; transportation system efficiency projects, policies and strategies; and future studies. In addition, the draft Update to the *Year 2045 SATP* includes discussion regarding mitigation of environmental impacts of major transportation projects recommended in the plan. Finally, the main body of the draft Update to the *Year 2045 SATP* contains a financial plan component.

Plan appendices include: a glossary of terms; documentation of meeting federal planning requirements enacted since approval of the original *Year 2045 SATP*; the air quality conformity analysis for the plan; financial plan supporting documentation; a statement on impacts of projects in the Update to the *Year 2045 SATP* on environmental justice; documentation of the public participation process for the plan (reserved); minutes of the multiagency environmental consultation meeting (reserved); and Sheboygan Metropolitan Planning Organization (MPO) Technical and Policy Advisory Committee membership.
