**Agenda Item #1:** Call Meeting to Order

Marshall Black, Parks Planner with the City of Manitowoc introduced himself and opened the meeting.

**Agenda Item #2:** Project Introduction

M. Black introduced the project by stating that the City has consulted with Bay Lake Regional Planning Commission (Bay Lake) to conduct a study and develop a Bike & Pedestrian Master Plan for the City. M. Black continued by highlighting the purpose of the plan, previous relevant City plans, and what this plan will accomplish.

Agenda Item #3: Introductions

All persons present introduced themselves, provided some background about their interest in this plan and any involvement with related interest groups.

**Agenda Item #4:** Advisory Committee – Roles & Responsibilities

M. Black mentioned that this is an Ad Hoc committee and explained the purpose of the committee, which is to oversee the development of the plan and provide feedback during project milestones and to promote the plan to affiliated organizations.

**Agenda Item #5:** Tentative Meeting Schedule

M. Black presented tentative dates for Advisory Committee meetings to be April 27, July 6, Sep. 7, Nov. 2. Also discussed the 2 public meetings – the first is scheduled for March 10 at 5:30pm at the Senior Center and the second has a tentative date of Sep. 14.

**Agenda Item #6:** Project Overview & Schedule

Sydney Swan, Economic Development Planner with Bay Lake Regional Planning Commission provided an overview of the project and public participation schedule, which mentioned the need for "pop-up" meetings that could be conducted by

Advisory Committee Members at various local events. S. Swan provided a summary of plan components, which are an introduction, existing conditions, need for improvements, recommended network and facilities, policy and program recommendations, and implementation.

#### **Agenda Item #7:** Work Completed Thus Far

S. Swan presented work completed thus far relating to the existing conditions, which comprised of: City and regional Plans that relate to this plan and summarized data collected such as road right-of-way statistics, sidewalk inventory, traffic counts, and bike/pedestrian crashes. S. Swan identified the next steps to be the Public Meeting on March 10, Bay Lake's rollout of public online interactive map/survey, and next Advisory Committee meeting in April.

**Discussion:** Group discussed the meaning of a sharrow, which is essentially painting a designated symbol on a normal vehicle lane on a roadway to indicate that it is to be shared with bicyclists, and discussed the locations of such that presently exist in the City. A question was answered which clarified that this plan is to cover all types of bike/pedestrian facilities such as bike paths, shared-use paths, sidewalks, trails, on-road, and off-road.

## **Agenda Item #8:** Visioning Exercise

S. Swan introduced an activity where the group breaks into smaller groups of 4 and each member answers 2 questions, being: In the next 5 years, where you hope to walk/bike to and from in the City? Regionally Speaking, where do you hope to bike to and from in the next 20 years?

On a map, each person placed 1 sticker on their starting location and 1 sticker on their destination.

**Discussion:** Group discussed their vision and why it was important to them and/or the community. Different locations were mentioned, but some recurring themes were identified. Some ideas were as follows:

- A corridor that connects the West side of the City (Harbortown area, Camp Vits, Silver Lake College) to the East side of the City (Downtown, CN peninsula property, Mariners Trail).
- A corridor that continues South from Downtown/end of Mariners Trail near the lakeshore to Silver Creek Park.
- A corridor on the West side of the City that allows safe North/South transportation for bike/ped.
- Connection between Devils River State Trail and Mariners Trail.
- Safe route from neighborhoods with schools on the North/Northeast side of the City out to Indian Creek Park.
- A river corridor on the North side of Manitowoc River from Downtown to Manitou Park, with hopes of eventually connecting to Schuette Park across the river.
