## **Regional Comprehensive Plan Update**

Since the completion of the *Bay-Lake Regional Planning Commission Regional Comprehensive Plan* in 2005, many changes have taken place across northeast Wisconsin. In our ongoing efforts to provide proper guidance to the counties and communities in northeast Wisconsin, the Bay-Lake Regional Planning Commission (BLRPC) is beginning the process of updating the Regional Comprehensive Plan. The Regional Plan covers the eight-county Bay-Lake Region in northeast Wisconsin. It serves as an advisory policy document to guide where future conservation, growth, and development should occur within the region, while keeping with BLRPC's planning principles.

A recent grant award through the Wisconsin Coastal Management Program will assist with updates to the Natural Resources; Housing; Land Use; and Implementation elements of the existing Regional Plan. The BLRPC's Regional Transportation Work Program, as well as Economic Development Administration (EDA) funding, will help to update the remaining elements of the Regional Plan. In order to ensure that the Regional Plan update addresses the variety of issues found in each of BLRPC's eight counties, the BLRPC has established a Technical Advisory Committee consisting of representatives for each of the counties, in addition to a variety of organizations and agencies.

its hazard mitigation plan. The plan is one of the first in Wisconsin to integrate climate change impacts. The plan steering committee recognized the strength of a plan where decisions are based on current hazard trends over the reliance on data of past hazard events.

The steering committee worked with the Bay-Lake Regional Planning Commission and the Sea Grant Institute using a community assessment tool to evaluate climate impacts for the county. As a result, the climate change assessment became part of the County's hazard mitigation plan. The plan is currently being reviewed by FEMA. ## **Pavement Rating Assistance**

Wisconsin State Statute 86.302(2) requires each municipality and county to submit surface condition ratings for all local roads under their jurisdiction to the Wisconsin Department of Transportation (WisDOT) every two years. The next submissions to WisDOT are due by December of this year.



Just as was done in 2013, Commission staff will be providing assistance to communities to meet the pavement rating requirement. A majority of these services will be free of charge to Commission members, while non-member communities will be charged time and materials. # **Sheboygan Metropolitan Planning Organization (MPO) Activities**

Final production of the *Year 2045 Sheboygan Area Transportation Plan (SATP)* took place in June. All participating communities in the MPO area, as well as Sheboygan County, Shoreline Metro and the WisDOT Northeast Region have been given a hard copy of the plan, with all remaining members of the MPO Technical and Policy Advisory Committees receiving a CD copy of the plan. A copy of the plan has also been transmitted to the Mead Public Library in Sheboygan. The final plan has been posted to the Commission website.



A public hearing on the draft amendments to the *2015 - 2018 TIP* will be held on July 16. The amendments primarily impact the transit capital and street and highway project components of the *2015 - 2018 TIP*. The draft amendments to the *2015 - 2018 TIP* have been posted to the Commission website.

Upcoming items in the MPO program will include continued discussion of potential funding of projects with Surface Transportation Program (STP) Urban funds in the 2015 - 2020 cycle.

#### myBeachCast Mobile App Now Available

The Great Lakes Commission has released updated versions of the *myBeachCast* <u>iPhone</u> and <u>Android</u> mobile app. *myBeachCast* provides swim advisories, weather conditions, and beach hazard alerts for more than 2,000 beaches in the Great Lakes region.



Beach hazard alerts will include statements when high winds and waves, and strong and dangerous currents are present or forecasted. The app also connects to health department databases to alert users of contamination advisories.
