## Amendment \#3 to the 2016 Coordinated Public Transit - Human Services Transportation Plan for Kewaunee County, Wisconsin

The "Fixing America's Surface Transportation" (FAST) Act requires the county Coordinated Public Transit - Human Services Transportation Plan to identify an approved program of projects prior to distribution of funds from the Section 5310 (Enhanced Mobility of Seniors and Individuals with Disabilities) program. Two other programs that were previously included in Coordinated Public Transit - Human Services Transportation Plans (Section 5316, the Job Access and Reverse Commute (JARC) Program, and Section 5317, the New Freedom Program) were discontinued in the previous federal surface transportation legislation (the "Moving Ahead for Progress in the $21^{\text {st }}$ Century (MAP-21) Act), but were rolled into other existing programs; Section 5316 was rolled into Section 5311 in the case of Kewaunee County, while Section 5317 was rolled into Section 5310; these changes remained intact in the FAST Act.

The Bay-Lake Regional Planning Commission, the Kewaunee County Human Services Department, and East Shore Industries, Inc., after consulting with the Kewaunee County Transportation Coordinating Committee and with interested parties in Kewaunee County, has updated the 2016 Coordinated Public Transit - Human Services Transportation Plan for Kewaunee County, Wisconsin, to reflect the amended program of projects for fiscal years 2017 through 2021.

The amended Table 6 which follows supersedes previous versions of Table 6 outlining the program of projects; these were found on page 18 of the original 2016 Coordinated Public Transit - Human Services Transportation Plan for Kewaunee County, Wisconsin, as well as on page 2 of Amendment \#1 to this plan (June, 2017).

# Kewaunee County Transportation Coordinating Committee Meeting December 11 ${ }^{\text {th }}, 2018$ 10:30- at 810 Lincoln Street 

Present for the meeting were Melissa Annoye, Laurie Bouche, Tracy Nollenberg, Jodi Vandervest, Candace Hanmann, Tracy Nelson, Jeff Agee-Aguayo of BayLake Regional Planning Commission, Lee Luft, Wendy Hutterer, Lynn Clark, Kaye Shillin, Dan Daul, Jean Robinson, Cindy Kinnard, and LeAnne Loveless and Sandy Popp both from Options for Independent Living.

This meeting is also being held in conjunction with the public hearing for the 85.21 grant application for 2019.

There was a correction made to the agenda to indicate 2018 program review, not 2017.
A motion was made to approve the agenda and the minutes from last meeting by Bob Mattice and seconded by Lee Luft. Motion carried.

Agency updates: Bob Mattice reported that the budget had been submitted to the county administrator's office and has been passed as of November $5^{\text {th }}$. Bob also stated that Kim Vandermoss, who has worked in the Economic Support Department for many years, has announced her retirement effective January 18 ${ }^{\text {th }}$. Tracy Koller has been hired as of November $12^{\text {th }}$ to fill that position and is currently going through the training process. Ashley Thornton has been hired to fill the open position in the Children \& Families Unit created by Ursula Tamarack's resignation. Ashley also started on November 12 ${ }^{\text {th }}$. Bob has announced his retirement as Director of Kewaunee Department of Human Services effective April 30th 2019. The director position is posted. Joanne Tulachka, Crisis Coordinator, Mental Health/ AODA Counselor resigned as of November $16^{\text {th }}$ for a job in the behavioral health field. Jacob Kumpfer has completed the training requirements and has taken over her position which leaves an opening for a CCS Facilitator. The open CCS job position is in the process of being posted.

Transportation Program updates: Jeff Agee-Aguayo from the Bay Lake Regional Planning Commission was present, as requested at the last meeting, to make amendments to the regional plan regarding ESI's change in vehicle request timelines. The changes could not be made at the last meeting due to the need to provide public notice. Jeff handed out a copy of the revised table 6 and program of projects which he then reviewed with committee. Jeff also noted that he and Melissa had provided stakeholders who are not part of this committee, with the updated plan as required.

A motion to approve the amended action plan was made by Cindy Kinnard and seconded by Laurie Bouche. Motion carried.

2018 Program Review: Melissa reviewed service numbers comparing January through October of 2017 to the same time period of 2018. Her review showed that the driver escort numbers continue to climb, having provided 1128 more rides, while the other programs
only varied slightly. The Grant Van, Kewaunee Van, and Algoma Bus programs remain somewhat consistent. Although the Algoma Bus numbers were close, they have been steadily declining over the last several years. The number of assessments also remained consistent. There have been 3 new drivers this year as opposed to 5 in 2017. We currently have 23 volunteer drivers available but will be losing 2 for the winter months in a few weeks. This report was followed by some committee discussion regarding volunteer driver recruitment. It was agreed by all that finding volunteers continues to be a struggle not only here, but in surrounding counties and the ADRC as well.

Volunteer driver training update: The fall session of Volunteer Driver Training was held at the end of November. Focus points were serving children with special needs, adult protection, and when to make reports. Lunch was also provided. Melissa asked for committee input of suggested topics for the upcoming spring training. That training is scheduled to include the annual blood borne pathogen training.

Update on the transporting of children: A new project description for transporting children and estimated costs associated with that project has been added to the 85.21 grant application for 2019. Discussion followed on the development of that project.

Update on the 53.10 grant van: Melissa received a call from A\&J Mobility, who will be supplying the vehicle, to review available options. After internal discussion, it was decided that we would have a power fold ramp upgrade and would remove the standard $2^{\text {nd }}$ row seat so that securing the wheelchair is easier for the driver. We are expected to receive the vehicle sometime in spring of 2019.

Update on 85.21 grant application for 2019: Kewaunee County is applying for grant funds in the amount of $\$ 72,389$ which requires a local match in the amount of $\$ 14,478$. Public notice was provided in the Green Bay Press Gazette on November 3rd to inform of today's meeting. The Human Services Committee will review the application on Thursday. The application has some changes from 2018 including the reduction of days covered for the Algoma Route. As the Algoma Route numbers have been steadily declining, it was decided to reduce the numbers of days per week from 5 to 3 . The bus will be running $\mathrm{M}-\mathrm{W}-\mathrm{F}$ which will allow us to have a paid driver for 2 days a week for the Journey's Club van route. We will be looking to have some of our current volunteer drivers hired and paid by Helping Hands for the Journey's Club route. Also changed on the new plan, the Kewaunee Van Project has been added to the project with Driver Escort and Grant Van rather than being recorded separately. We will continue to only utilize the white van within Kewaunee County because of the age/condition of the van. Another addition to the plan, as previously discussed, was the new project for transporting children. This program will be similar to the driver escort program although it will have a paid driver. Specifics regarding ages, parent/guardian permission, etc., will be provided within the Transportation Manual. The paid driver will be allowed to use their own vehicle and be reimbursed for mileage, or use the county vans. The program cost will use the wage rate of $\$ 12.00 / \mathrm{hr}$ for 10 hours/week, plus the mark up for Helping Hands and will also account for estimated passenger revenue. A transmittal letter was received from Scott Feldt indicating support of the program and confirming that the county will provide the $20 \%$ match.

A motion to submit the 2019 Grant Application as presented was made by Bob Mattice and seconded by Lee Luft. Motion carried.

Next meeting date was set for March $19^{\text {th }}$ at 10:30.
