- I. Call to Order: Larry Neuens called the meeting to order at 10.05 a.m.
- II. **Approval of Agenda:** Moved by Dan Koski and seconded by Dennis Kroll that the agenda be approved as presented. Motion carried, with all voting aye on a voice vote.
- III. **Approval of Minutes:** Moved by Dan Koski and seconded by Dennis Kroll that the minutes of the November 14, 2023, meeting be approved, with 4 voting aye on a voice vote and 1, Ed Procek, abstaining from voting.
- IV. **Policies and Procedures Manual Amendments:** Brandon Robinson proposed the addition of the Remote Work policy.
